### UDVMA Form 2: Application for \$2500 Cash at Closing

**Purpose:** The purpose of this form is to validate veteran status qualifications to participate in the Utah First-Time\* Homebuyer Grant program. This program is subject to funding availability and will run August 1, 2018<sup>1</sup> to June 20, 2019 unless extended by the Utah Legislature.

**Procedure:**

- 1) Submit this form (2 pages) to the Utah Department of Veterans and Military Affairs by mail, fax or in-person to: 550 Foothill Drive, Suite 105, Salt Lake City, UT 84113. Fax: 801-326-2369. Also required:
  - a. VA Home Loan Certificate of Eligibility
  - b. Evidence of recency of service within the last 5 years. Acceptable documentation includes a DD214 or similar, W-2, LES or ID card for currently serving.
  
- 2) Once assigned a validation number below, provide a copy to your mortgage lender.
