General Information regarding VA benefits - All criteria is established by the U.S. Congress and implemented by the Veterans Administration

Federal Benefit	Federal Requirements	Links
VA Healthcare Enrollment	All Veterans who meet basic service and discharge requirements and who were exposed to toxins and other hazards while serving our country—at home or abroad—are now eligible for VA health care. This includes all Veterans who served in the Vietnam War, Gulf War, Iraq, Afghanistan, or any other combat zone after 9/11. Apply today. Service-Connected Disability (SCD)	Each Condition must meet the following VA criteria: 1. A Qualifying Period of Service - verified by DD214 2. Current Medical Diagnosed Condition 3. Wartime Veteran Pension/ NSC Pension	Must meet the following criteria: 1. Wartime Service -verified by DD214/Orders 2. Below Net Worth [\$159,240 for 2025] 3. Meet service requirements 4. Survivor of Wartime Veteran Pension/Death Pension	Must meet the following Criteria – <i>ALL Survivor benefits are contingent upon Veteran's eligibility</i> 1. Married at time of Veteran's Death 2.
